- 1. Tender Documents with detailed Specifications, Quantities, Criteria, Terms and Conditions will be issued to those Vendors/Suppliers who will provide proof of Tender Fee in hard and soft form to Treasurer Office (treasurer@ajkuob.edu.pk).
- 2. The Bidder shall submit a CDR equivalent to 3% of the total bidding amount for each individual item.
- 3. Tender fee (Non-Refundable) is Rs. 2,000 which may be paid through Bank Challan in AJ&K Bank Main Branch Bhimber or Demand Draft in favor of Treasurer AJ&KUoB. Receipt may be enclosed with the financial bid.
- 4. Call Deposit Receipt (CDR Refundable) in favor of the Treasurer is also required.
- 5. All Government / Local Taxes will be deducted at the time of payment under rules.
- 6. Quantity of Items given in tender document may be increased and decreased at time of supply order as per approval of the competent authority up to 15% of quantity given in tender document.
- 7. Incomplete/conditional tender will not be entertained.
- 8. All pages of Quotations should be numbered & dully signed in by authorized person. Separate quotation for each head is required.
- 9. PPRA rules shall be followed during the course of procurement.
- 10. Single stage, Single envelop procurement proceeding of PPRA Rules shall be opted.
- 11. Black listed firms / companies/suppliers/bidders/distributers are prohibited for participation and all bidders shall furnish an affidavit /certificate that they are neither black listed nor in conflict with Govt. anywhere in the territory of the state of AJ&K, Federally administrated areas or Islamic Republic of Pakistan.
- 12. The procuring agency reserves the right to reject all bids or proposals at any time prior to the acceptance of a bid or proposal by invoking PPRA Rules.
- 13. Interested firms are invited to submit their sealed bids/tenders on or before 30th May 2025 (Friday) till 10:00 AM in the office of the under signed.
- 14. Tender will be opened on same day at 10:30 AM in Main Campus AJ&KUoB.
